On November 2, 2006 the Alberta Energy and Utilities Board (EUB or Board) commenced the AltaLink Management Ltd. (AltaLink) 500 kV proceeding (the Proceeding). The hearing involved 37 sitting days and the filing of extensive written argument and reply. On September 30, 2007 the Board issued Decision 2007-075 in which it declared that the Proceeding, and two related proceedings, were void on the ground of reasonable apprehension of bias.

On March 12, 2008 the Alberta Energy and Utilities Board (EUB or Board) established a division of the Board consisting of Acting Board Members to consider cost claims arising from Cost Application No. 1504491 (the Hearing Costs Panel). Each member of the Hearing Costs Panel was appointed to the EUB's acting Board Members list after the issuance of EUB Decision 2007-075. No member of the Hearing Costs Panel has had any previous involvement in any EUB decisions relating to the 500 kV applications, including the Section 34 NID application.

The Hearing Costs Panel has reviewed correspondence from Mr. Block dated March 24, 2008, on behalf of AltaLink, in which a negotiated settlement of the legal fees, expenses, and GST of Mr. Roy W. Elander is proposed.

The Hearing Costs Panel understands that Mr. Elander acted as counsel for John and Virginia Safronovich, Dale and Jason Smith, and Mike and Shelia Ruby at the Altalink 500 kV proceeding. These interveners filed the following claim for Local Intervener Costs with the Board on September 19, 2007.

The Hearing Costs Panel understands that Mr. Elander has accepted AltaLink's offer of \$72,544.04 in full satisfaction of his legal fees, expenses, and GST. The amount negotiated is inclusive of Mr. Elander's advance funding award made by the Board on June 20, 2007 in the amount of \$28,136.95. The Hearing Costs Panel understands that the settlement amount addresses only Mr. Elander's portion of the claim and that the claims of Dale Smith, Jason Smith, and John and Virginia Safronovich remain outstanding. The Hearing Costs Panel confirms that it will decide upon these, and all other outstanding cost claims in the final Cost Order that it will issue for the Altalink 500 kV proceeding.

The Hearing Costs Panel considers the settlement amount to be consistent with the Board's Scale of Costs and reasonable given the tasks undertaken, as described in Mr. Elander's statements of account. In addition, the Hearing Costs Panel finds that it was reasonable for Mr. Elander's clients to participate in this proceeding, and that such participation was in the public interest.

As the Hearing Costs Panel is satisfied that the settlement amount accords with the Scale of Costs, is reasonable and prudent, and in the public interest it hereby approves the settlement proposed by AltaLink.

ORDER

IT IS HEREBY ORDERED:

1. AltaLink Management Ltd. shall pay Local Intervener Costs in the amount of \$72,544.04, to Mr. Roy W. Elander as full satisfaction of the legal fees, expenses and GST claimed by Dale Smith, Jason Smith, and John and Virginia Safronovich for Cost Application No. 1504491.
