IN TOWNSHIP 58, RANGE 12, WEST OF THE 4th MERIDIAN: Sections 2, 4, 6, 8, 17-18

IN TOWNSHIP 58, RANGE 13, WEST OF THE 4th MERIDIAN: Section 25
