ALBERTA ENERGY REGULATOR

The Alberta Energy Regulator (AER) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

1) The following table shows the specified pools and wells in the ELNORA Field wherein production may be commingled in the wellbore:

2) Coalbed methane and non associated gas production from the EDMONTON GRP, HORSESHOE CANYON FM, BEARPAW FM, LETHBRIDGE, RIBSTONE CREEK MBR, VICTORIA MBR, and BROSSEAU MBR may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 35, RANGE 23, WEST OF THE 4th MERIDIAN: Sections 8, 17-18, 27

3) Coalbed methane and non associated gas production from the EDMONTON GRP, HORSESHOE CANYON FM, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 23, WEST OF THE 4th MERIDIAN: Section 34

IN TOWNSHIP 34, RANGE 22, WEST OF THE 4th MERIDIAN: Sections 4, 10-11, 14, 16, 18, 20, 22, 28-30, 32, 34

IN TOWNSHIP 34, RANGE 23, WEST OF THE 4th MERIDIAN: Sections 4, 10, 14, 24, 26, 32, 34

IN TOWNSHIP 35, RANGE 22, WEST OF THE 4th MERIDIAN: Sections 10, 16, 19-20, 29-30, 32

IN TOWNSHIP 35, RANGE 23, WEST OF THE 4th MERIDIAN: Sections 2, 11-12, 14, 24

4) Coalbed methane and non associated gas production from the HORSESHOE CANYON FM and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 23, WEST OF THE 4th MERIDIAN: Sections 16, 20, 28, 30

IN TOWNSHIP 35, RANGE 23, WEST OF THE 4th MERIDIAN: Sections 22 and 28

5) Non associated gas production from the BELLY RIVER GRP may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 23, WEST OF THE 4th MERIDIAN: Section 34

IN TOWNSHIP 34, RANGE 23, WEST OF THE 4th MERIDIAN: Sections 1-4, 10-11, 13-16, 23-26, 32, 34-36

6) Non associated gas production from the BELLY RIVER GRP and BASAL BELLY RIVER SD may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 22, WEST OF THE 4th MERIDIAN: Sections 4, 6-7, 10-11, 14, 16-24, 28-33, 36

IN TOWNSHIP 35, RANGE 22, WEST OF THE 4th MERIDIAN: Sections 3-9, 16-21, 24, 29-30, 32

IN TOWNSHIP 35, RANGE 23, WEST OF THE 4th MERIDIAN: Sections 1-2, 9, 11-14, 23-25
