The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

1) The following table shows the specified pools and wells in the **ERSKINE Field** wherein production may be commingled in the wellbore:

f)	ERSKINE BLAIRMORE Q, ERSKINE BLAIRMORE R, and ERSKINE BLAIRMORE Y	All
g)	ERSKINE BLAIRMORE GG, ERSKINE BLAIRMORE HH, ERSKINE GLAUCONITIC F, ERSKINE GLAUCONITIC Y, and ERSKINE OSTRACOD A	All

2) Coalbed methane and non associated gas production from EDMONTON GRP and HORSESHOE CANYON FM may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 39, RANGE 20, WEST OF THE 4th MERIDIAN: Section 18

IN TOWNSHIP 39, RANGE 21, WEST OF THE 4th MERIDIAN: Section 2

3) ¹ Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM CBM DBSL, HORSESHOE CANYON FM CBM RS, HORSESHOE CANYON FM CBM WAYN, and HORSESHOE CANYON FM CBM UHSC may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 39, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 11, 14, 16, 22

4) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 38, RANGE 21, WEST OF THE 4th MERIDIAN: Section 36

IN TOWNSHIP 39, RANGE 20, WEST OF THE 4th MERIDIAN: Sections 17, 20, 29

IN TOWNSHIP 39, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 10, 12, 24

5) Coalbed methane, associated gas, non associated gas, and shale gas production from EDMONTON GRP and BELLY RIVER GRP may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 40, RANGE 20, WEST OF THE 4th MERIDIAN: Sections 13 and 25

6) Coalbed methane and non associated gas production from HORSESHOE CANYON FM and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 38, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 29 and 32

IN TOWNSHIP 39, RANGE 21, WEST OF THE 4th MERIDIAN: Section 4
