ENERGY RESOURCES CONSERVATION BOARD

The Energy Resources Conservation Board (ERCB) pursuant to the Oil and Gas Conservation Act, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

1) The following table shows the specified pools and wells in the **Hangingstone Field** wherein production may be commingled in the wellbore:
