The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

1) The following table shows the specified pools and wells in the **LEO Field** wherein production may be commingled in the wellbore:

## Pools

- a) LEO LOWER EDMONTON B, LEO LOWER EDMONTON N, LEO BELLY RIVER J, LEO BELLY RIVER S, LEO BELLY RIVER V, LEO BELLY RIVER X, LEO UPPER MANNVILLE F, and LEO MFP8540 BSL BELLY RIV
- b) LEO BELLY RIVER U and LEO BASAL BELLY RIVER F

2) <sup>1</sup> Coalbed methane and non associated gas production from EDMONTON GRP and HORSESHOE CANYON FM may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 17, WEST OF THE 4th MERIDIAN: Section 21: Southeast and Southwest (see clause 7)

3) <sup>1</sup> Coalbed methane and non associated gas production from EDMONTON GRP and HORSESHOE CANYON FM may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 17, WEST OF THE 4th MERIDIAN: Section 21: Northeast and Northwest (see clause 8)

4) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM CBM WAYN, HORSESHOE CANYON FM CBM RS, and HORSESHOE CANYON FM CBM DBSL may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 17, WEST OF THE 4th MERIDIAN: Section 17

5) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM CBM WAYN, HORSESHOE CANYON FM CBM DBSL, HORSESHOE CANYON FM CBM RS, LETHBRIDGE, RIBSTONE CREEK MBR, VICTORIA MBR, and BROSSEAU MBR may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 17, WEST OF THE 4th MERIDIAN: Section 15

6) Coalbed methane production from HORSESHOE CANYON FM CBM WAYN, HORSESHOE CANYON FM CBM RS, HORSESHOE CANYON FM CBM DBSL, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 17, WEST OF THE 4th MERIDIAN: Sections 3, 9-10, 16, 20

- 7) <sup>1</sup> Wells within the south half of section 21-034-17W4 may not produce commingled above a depth of 133.5 metres true vertical depth.
- 8) <sup>1</sup> Wells within the north half of section 21-034-17W4 may not produce commingled above a depth of 158.0 metres true vertical depth.
- 9) <sup>1</sup> Board Order No. MISC 2006-40 is rescinded.
- 10) Board Order No. MU8193 is rescinded.
