ALBERTA ENERGY REGULATOR

The Alberta Energy Regulator (AER) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

1) The following table shows the specified pools and wells in the **MEDICINE LODGE Field** wherein production may be commingled in the wellbore:

c)	MEDICINE LODGE NOTIKEWIN C, MEDICINE LODGE FALHER A, MEDICINE LODGE BLUESKY B, and MEDICINE LODGE CADOMIN D	All
d)	MEDICINE LODGE GETHING A, MEDICINE LODGE GETHING B, and MEDICINE LODGE CADOMIN B	All

2) Non associated gas production from the SMOKY RIVER GRP, DUNVEGAN FM, FORT ST JOHN GRP, and BULLHEAD GRP may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 51, RANGE 20, WEST OF THE 5th MERIDIAN: Sections 31 and 32

IN TOWNSHIP 51, RANGE 21, WEST OF THE 5th MERIDIAN: Sections 25-26, 33-36

IN TOWNSHIP 52, RANGE 20, WEST OF THE 5th MERIDIAN: Sections 5-8, 17-19

IN TOWNSHIP 52, RANGE 21, WEST OF THE 5th MERIDIAN:

Sections 1-5, 8-10, 12-13, 15-17, 22-25, 31

IN TOWNSHIP 53, RANGE 21, WEST OF THE 5th MERIDIAN: Sections 6-8

IN TOWNSHIP 53, RANGE 22, WEST OF THE 5th MERIDIAN: Sections 1, 12-13

3) Non associated gas production from the SPIRIT RIVER FM, BLUESKY FM, and BULLHEAD GRP may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 52, RANGE 21, WEST OF THE 5th MERIDIAN: Sections 28, 33-35

IN TOWNSHIP 53, RANGE 21, WEST OF THE 5th MERIDIAN: Section 5
