The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

2) Non associated gas production from EDMONTON GRP and LOWER EDMONTON may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 40, RANGE 28, WEST OF THE 4th MERIDIAN: Section 34

IN TOWNSHIP 41, RANGE 27, WEST OF THE 4th MERIDIAN: Section 15

IN TOWNSHIP 41, RANGE 28, WEST OF THE 4th MERIDIAN: Section 5

3) ¹ Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM CBM RS, HORSESHOE CANYON FM CBM WEAV, HORSESHOE CANYON FM CBM WAYN, HORSESHOE CANYON FM CBM DBSL, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 42, RANGE 27, WEST OF THE 4th MERIDIAN: Section 32

4) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, BELLY RIVER GRP, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 41, RANGE 27, WEST OF THE 4th MERIDIAN: Sections 2-4, 10-12, 18, 20, 28-29

5) Coalbed methane and non associated gas production from HORSESHOE CANYON FM and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 41, RANGE 27, WEST OF THE 4th MERIDIAN: Sections 32, 34, 36

IN TOWNSHIP 41, RANGE 28, WEST OF THE 4th MERIDIAN: Section 24

IN TOWNSHIP 42, RANGE 1, WEST OF THE 5th MERIDIAN: Sections 10, 22, 24, 34, 36

IN TOWNSHIP 42, RANGE 27, WEST OF THE 4th MERIDIAN: Sections 2, 4, 10-12, 14
