The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

1) The following table shows the specified pools and wells in the **RICH Field** wherein production may be commingled in the wellbore:

a)	RICH GLAUCONITIC B and RICH GLAUCONITIC C	All
b)	RICH GLAUCONITIC F and RICH MFP8506 BELLY RIVER	All
c)	RICH GLAUCONITIC H and RICH GLAUCONITIC N	All
d)	RICH GLAUCONITIC L and RICH LOWER MANNVILLE J	All

2) Coalbed methane and non associated gas production from EDMONTON GRP may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 22, 27-28, 34-35

3) ¹ Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM CBM RS, HORSESHOE CANYON FM CBM UHSC, HORSESHOE CANYON FM CBM WAYN, and HORSESHOE CANYON FM CBM DBSL may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 20, WEST OF THE 4th MERIDIAN: Section 16

4) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, BEARPAW FM, LETHBRIDGE, RIBSTONE CREEK MBR, VICTORIA MBR, and BROSSEAU MBR may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 20, WEST OF THE 4th MERIDIAN: Section 7

5) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, BELLY RIVER GRP, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 20, WEST OF THE 4th MERIDIAN: Sections 11 and 14

IN TOWNSHIP 35, RANGE 22, WEST OF THE 4th MERIDIAN: Section 14

6) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 19, WEST OF THE 4th MERIDIAN: Section 19

IN TOWNSHIP 34, RANGE 20, WEST OF THE 4th MERIDIAN: Sections 12, 15, 23-24, 27, 34

IN TOWNSHIP 34, RANGE 22, WEST OF THE 4th MERIDIAN: Section 36

IN TOWNSHIP 35, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 4, 16, 18

IN TOWNSHIP 35, RANGE 22, WEST OF THE 4th MERIDIAN: Section 24

7) Non associated gas production from BELLY RIVER GRP and BASAL BELLY RIVER SD may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 20, WEST OF THE 4th MERIDIAN: Sections 21 and 31

IN TOWNSHIP 35, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 14, 18, 22-23, 25, 35

IN TOWNSHIP 35, RANGE 22, WEST OF THE 4th MERIDIAN: Section 15
