The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

1) The following table shows the specified pools and wells in the **ROWLEY Field** wherein production may be commingled in the wellbore:

2) ¹ Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM CBM WAYN, HORSESHOE CANYON FM CBM DBSL, HORSESHOE CANYON FM CBM RS, and HORSESHOE CANYON FM CBM UHSC may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 20, WEST OF THE 4th MERIDIAN: Section 20

3) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, BEARPAW FM, LETHBRIDGE, RIBSTONE CREEK MBR, VICTORIA MBR, and BROSSEAU MBR may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 31, RANGE 20, WEST OF THE 4th MERIDIAN: Sections 28-29, 32-34

IN TOWNSHIP 32, RANGE 21, WEST OF THE 4th MERIDIAN: Section 14

IN TOWNSHIP 34, RANGE 20, WEST OF THE 4th MERIDIAN: Section 5

4) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, BELLY RIVER GRP, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 32, RANGE 21, WEST OF THE 4th MERIDIAN: Section 36

5) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, BELLY RIVER GRP, and TABER SD may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 32, RANGE 20, WEST OF THE 4th MERIDIAN: Section 34

IN TOWNSHIP 33, RANGE 20, WEST OF THE 4th MERIDIAN: Sections 4, 10, 13-16, 23-24

6) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 31, RANGE 20, WEST OF THE 4th MERIDIAN: Sections 23, 25, 36

IN TOWNSHIP 32, RANGE 20, WEST OF THE 4th MERIDIAN: Sections 2, 4, 7, 9, 13-16, 18-19, 21-23, 27, 30

IN TOWNSHIP 32, RANGE 21, WEST OF THE 4th MERIDIAN: Section 27

IN TOWNSHIP 33, RANGE 20, WEST OF THE 4th MERIDIAN: Sections 3, 6, 9, 11, 19, 25, 29-32, 34-35

IN TOWNSHIP 33, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 1 and 12

IN TOWNSHIP 34, RANGE 20, WEST OF THE 4th MERIDIAN: Sections 1-2, 4, 6, 9
