The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

1) The following table shows the specified pools and wells in the **RUMSEY Field** wherein production may be commingled in the wellbore:

Pools

RUMSEY GLAUCONITIC A and RUMSEY GLAUCONITIC Q

All

B) RUMSEY GLAUCONITIC A and RUMSEY GLAUCONITIC A and RUMSEY LOWER MANNVILLE D

2) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, BEARPAW FM, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 22-25, 27, 34-36

IN TOWNSHIP 33, RANGE 22, WEST OF THE 4th MERIDIAN: Section 36

IN TOWNSHIP 34, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 1-5, 9-12, 14-18, 21, 23

IN TOWNSHIP 34, RANGE 22, WEST OF THE 4th MERIDIAN: Section 12

3) <sup>1</sup> Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, BEARPAW FM, LETHBRIDGE, RIBSTONE CREEK MBR, VICTORIA MBR, and BROSSEAU MBR may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 13-14, 23-24

4) Coalbed methane production from HORSESHOE CANYON FM may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 22-25, 27, 34-36

IN TOWNSHIP 34, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 1-3, 10-12, 16-18

5) Non associated gas production from BELLY RIVER GRP and BASAL BELLY RIVER SD may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 22-25, 27, 34-36

IN TOWNSHIP 33, RANGE 22, WEST OF THE 4th MERIDIAN: Section 36

IN TOWNSHIP 34, RANGE 21, WEST OF THE 4th MERIDIAN: Sections 1-3, 10-12, 16-18

IN TOWNSHIP 34, RANGE 22, WEST OF THE 4th MERIDIAN: Sections 1 and 12
