IN TOWNSHIP 71, RANGE 13, WEST OF THE 6th MERIDIAN: Sections 23-36

3) Non associated gas production from the DOIG FM and MONTNEY FM may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 74, RANGE 13, WEST OF THE 6th MERIDIAN: Section 33

IN TOWNSHIP 75, RANGE 12, WEST OF THE 6th MERIDIAN: Sections 21, 27, 33

IN TOWNSHIP 75, RANGE 13, WEST OF THE 6th MERIDIAN: Sections 20, 27, 29-32, 34-36
