ALBERTA ENERGY REGULATOR

IN TOWNSHIP 56, RANGE 21, WEST OF THE 5th MERIDIAN: Sections 7 and 18

IN TOWNSHIP 58, RANGE 22, WEST OF THE 5th MERIDIAN: Sections 19 and 28
