The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

1) The following table shows the specified pools and wells in the **THORSBY Field** wherein production may be commingled in the wellbore:

	Pools	Wells (Unique Identifier)
a)	THORSBY GLAUCONITIC D and THORSBY LOWER MANNVILLE M	All
b)	THORSBY GLAUCONITIC E and THORSBY LOWER MANNVILLE C (see clause 5)	All
c)	THORSBY GLAUCONITIC N and THORSBY LOWER MANNVILLE L	All
d)	THORSBY GLAUCONITIC Q and THORSBY OSTRACOD B	All

2) Coalbed methane, associated gas, non associated gas, and shale gas production from the EDMONTON GRP, HORSESHOE CANYON FM, and BELLY RIVER GRP may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 48, RANGE 1, WEST OF THE 5th MERIDIAN: Sections 13-14, 22-25, 27-28, 33

3) ¹ Coalbed methane production from the HORSESHOE CANYON FM may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 49, RANGE 1, WEST OF THE 5th MERIDIAN: Sections 1-2, 5-8, 11-14, 25-26, 35-36

IN TOWNSHIP 49, RANGE 2, WEST OF THE 5th MERIDIAN: Sections 1 and 12

IN TOWNSHIP 49, RANGE 27, WEST OF THE 4th MERIDIAN: Sections 16-21, 28-30

IN TOWNSHIP 49, RANGE 28, WEST OF THE 4th MERIDIAN: Sections 2, 11, 14, 26, 35

IN TOWNSHIP 50, RANGE 1, WEST OF THE 5th MERIDIAN: Section 1

IN TOWNSHIP 50, RANGE 28, WEST OF THE 4th MERIDIAN: Section 2

4) ¹ Coalbed methane production from the HORSESHOE CANYON FM CBM RBSL, HORSESHOE CANYON FM CBM UHSC, and HORSESHOE CANYON FM CBM WAYN may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 49, RANGE 1, WEST OF THE 5th MERIDIAN: Section 18

- 5) ¹ Segregated flow tests shall be conducted every three years on the Thorsby Glauconitic E and Lower Mannville C Pools.
- 6) ¹ Board Order No. MISC 2006-30 is rescinded.
- 7) Board Order No. MU7158 is rescinded.
