

ALBERTA ENERGY REGULATOR

The Alberta Energy Regulator (AER) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

Sections 2, 11-12, 27, 32, 34-36

IN TOWNSHIP 48, RANGE 6, WEST OF THE 4th MERIDIAN:

Sections 2, 10, 14, 36

IN TOWNSHIP 48, RANGE 7, WEST OF THE 4th MERIDIAN:

Sections 1, 4, 9, 11-12, 22, 24, 33, 36

IN TOWNSHIP 49, RANGE 5, WEST OF THE 4th MERIDIAN:

Sections 2, 4, 6-7, 9, 11-12, 28-29, 34

IN TOWNSHIP 49, RANGE 6, WEST OF THE 4th MERIDIAN:

Sections 2, 6, 23-25, 36

IN TOWNSHIP 49, RANGE 7, WEST OF THE 4th MERIDIAN:

Sections 4, 12, 16, 34, 36

IN TOWNSHIP 50, RANGE 6, WEST OF THE 4th MERIDIAN:

Sections 4, 10-11, 16, 20

IN TOWNSHIP 50, RANGE 7, WEST OF THE 4th MERIDIAN:

Sections 11, 29, 36

- 4) Non associated gas production from the WESTGATE FM and VIKING SANDSTONE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 47, RANGE 4, WEST OF THE 4th MERIDIAN:

Section 35
