EXAMINER REPORT RESPECTING TERRA ENERGY CORP. APPLICATION FOR A PIPELINE LICENCE UKALTA FIELD

1 RECOMMENDATION

Having completed a review of the application, and in accordance with Section 20 of the Alberta Energy and Utilities Board (EUB/Board) *Rules of Practice*, the examiner panel recommends that the Board accepts the request by Terra Energy Corp. (Terra) to withdraw Application No. 1382407.

2 APPLICATION

Pursuant to Part 4 of the *Pipeline Act*, Terra applied for a licence to construct and operate a pipeline (the proposed pipeline) for the purpose of transporting natural gas from an existing pipeline located in Legal Subdivision 7, Section 5, Township 57, Range 17, West of the 4th Meridian to an existing pipeline located at 03-08-57-17W4M. The proposed pipeline would be approximately 1.66 kilometres (km) in length with a maximum outside diameter of 88.9 millimetres and would transport natural gas with a maximum hydrogen sulphide (H₂S) concentration of 0.00 moles per kilomole (0.00 per cent H₂S). The proposed pipeline would be located approximately 20 km southeast of Smoky Lake, Alberta.

3 INTERVENTION

Lawrence Wasileyko (the intervener) is the registered owner of the southwest quarter of Section 8-57-17W4M and filed an objection to the proposed pipeline with the EUB. Terra and the intervener had been engaged in discussions in an effort to resolve the outstanding issues.

4 WITHDRAWAL OF APPLICATION

On August 5, 2005, Terra submitted to the EUB a written withdrawal of Application No. 1382407.
