1 DECISION

Having regard for the withdrawal of the request for review, the Alberta Energy and Utilities Board (EUB/Board) has hereby cancelled the public hearing scheduled to consider Pipeline Licence No. 46669 and confirms the licence to be in good standing.

2 INTRODUCTION

2.1 Application

On May 25, 2006, the Board approved Application No. 1458636 and issued Pipeline Licence No. 46669 to Compton Petroleum Corporation (Compton), pursuant to Part 4 of the *Pipeline Act*. Pipeline Licence No. 46669 is for the construction and operation of a pipeline for the purpose of transporting natural gas containing 0.00 moles per kilomole (0.0 per cent) of hydrogen sulphide from a well at Legal Subdivision (LSD) 7, Section 12, Township 15, Range 25, West of the 4th Meridian, to a pipeline tie-in point at LSD 10-14-15-25W4M. Licence No. 46669 was for a pipeline about 2.96 kilometres in length, with a maximum outside diameter of 168.3 millimetres.

2.2 Intervention and Hearing

On June 27, 2006, the Board received a letter from the owners of the north half of Section 11-15-25W4M, Gordon Hagg and Mary Lou Giles, who expressed concern that the subject pipeline had been approved without consideration of a letter of objection submitted to the Board on May 11, 2006. The Board regarded the June 27 letter as a request that it conduct a review hearing related to Pipeline Licence No. 46669, pursuant to Section 40 of the *Energy Resources Conservation Act*. The EUB registered the request as Application No. 1471310.

On October 30, 2006, the Board granted the request for a review hearing and registered the hearing as Proceeding No. 1488165. The purpose of the hearing was to determine whether the Board should confirm, vary, or rescind its decision to grant Pipeline Licence No. 46669. The Board was scheduled to hold the hearing in Champion, Alberta, on March 21, 2006.

3 DISCUSSION

Subsequent to the Board's issuance of Notice for Hearing, discussions continued between the parties and resulted in an agreement. The Board received correspondence dated March 13, 2007, from Gordon Hagg and Mary Lou Giles withdrawing their request for a review hearing. The Board accepted the request and the hearing was cancelled.
