1 DECISION

The Alberta Energy and Utilities Board (EUB/Board) has accepted the applicant's request to withdraw Application No. 1497248 and has cancelled the public hearing scheduled to consider the application.

2 INTRODUCTION

2.1 Application

Northrock Resources Ltd. (Northrock) applied to the EUB, pursuant to the *Oil and Gas Conservation Act*, for an order prescribing that all tracts within the drilling spacing unit comprising Section 30 of Township 63, Range 12, West of the 5th Meridian, be operated as a unit for the production of gas from the commingled Viking and Notikewin Formations through the well with the unique identifier of 00/12-30-063-12 W5/0.

2.2 Interventions

Milagro Energy Inc., which holds mineral rights in the upper zone of interest only, opposed the application, including the proposal to commingle zones and associated completion costs.

Glencoe Resources Ltd. (Glencoe) holds mineral rights in both zones and elected not to participate in the proposed dual completion. Glencoe objected to the actual drilling and proposed completion costs.

2.3 Hearing

The EUB issued a Notice of Hearing for the subject application on April 30, 2007. The Board was scheduled to hold a public hearing in Calgary, Alberta, on June 25, 2007, before Board Member J. D. Dilay, P.Eng. (Presiding Member) and Acting Board Members R. J. Willard, P.Eng., and F. Rahnama, Ph.D.

3 DISCUSSION

Following issuance of the Notice of Hearing, the parties continued negotiations and resolved the matter that had resulted in the filing of the application. On May 3, 2007, the applicant requested approval to withdraw the application and the Board subsequently approved the withdrawal. The Board issued a Notice of Cancellation of Hearing on May 4, 2007.
