EXAMINER REPORT RESPECTING ANDERSON ENERGY LTD. APPLICATION FOR A PIPELINE LICENCE SYLVAN LAKE FIELD

1 RECOMMENDATIONS

Having received Application No. 1561299, noting that it meets Energy Resources Conservation Board (ERCB/Board) requirements, and noting the receipt of a confirmation of nonobjection from the intervening party, the examiner panel recommends cancellation of the hearing and that Application No. 1561299 be approved.

2 INTRODUCTION

2.1 Application

Anderson Energy Ltd. (Anderson) applied to the ERCB in accordance with Part 4 of the *Pipeline Act* for approval to construct and operate a pipeline for the purpose of transporting natural gas from Legal Subdivision (LSD) 2, Section 25, Township 37, Range 5, West of the 5th Meridian, to a pipeline tie-in point at LSD 12-19-37-4W5M. The proposed pipeline would be about 1.35 kilometres (km) in length, with a maximum outside diameter of 114.3 millimetres, and would transport natural gas with a maximum hydrogen sulphide concentration of 0.0 moles per kilomole (0.0 per cent). The proposed pipeline would be located about 16 km northeast of Caroline, Alberta.

2.2 Intervention

The intervening party to this application was Emil Baron, who owns the land where part of the pipeline was proposed to be located. His objections were based on construction practices and maintenance of the proposed pipeline right-of-way.

2.3 Hearing

Board-appointed examiners were scheduled to hold a public hearing in Red Deer, Alberta, on September 11, 2008, before H. W. Knox, P.Eng. (Presiding Member), C. A. Crowfoot, and L. P. Touchette. A request to reschedule the hearing to the following day, September 12, was received, and this request was granted.

3 DISCUSSION

Anderson engaged in the ERCB's appropriate dispute resolution process with Mr. Baron. The process resulted in an agreement between the parties, and on September 9, 2008, a signed withdrawal of objection was received by the ERCB.
