1 DECISION

The Energy Resources Conservation Board (ERCB/Board) has accepted the request made by Theologian Management Ltd. and Highfield Stock Farms Inc. (Review Applicant) to withdraw its application for review and variance of the above pipeline licences and has cancelled the public hearing scheduled to consider the application.

2 INTRODUCTION

2.1 Background

MPP Ltd. (MPP) is the licensee of the following pipelines: Line 006 of Licence No. 36967, located from Legal Subdivision (LSD) 10, Section 25, Township 21, Range 29, West of the 4th Meridian, to LSD 7-25-21-29W4M; Line 004 of Licence No. 36968, located from LSD 7-35-21-29W4M to LSD 10-25-21-29W4M; and Line 001 of Licence No. 36976, located from LSD 14-36-20-29W4M to LSD 7-34-19-28W4M.

2.2 Description of Proceeding

The Review Applicant applied to the Board for a review hearing related to Pipeline Licences No. 36967, 36968, and 36976, pursuant to Section 39 of the *Energy Resources Conservation Act* and Section 48 of the *Energy Conservation Board Rules of Practice*. The Review Applicant also requested that the Board direct the licensee to alter, relocate, and/or install additional equipment to the above pipelines, pursuant to Section 33 of the *Pipeline Act*.

2.3 Hearing

The Board scheduled a public hearing in Calgary, Alberta, on September 29, 2009, before Board Members J. D. Dilay, P.Eng. (Presiding Member), G. Eynon, P.Geol., and B. T. McManus, Q.C.

3 DISCUSSION

On August 19, 2009, the Review Applicant notified the ERCB of its intent to withdraw its application, pursuant to Section 21 of the *Energy Resources Conservation Board Rules of Practice*. The Board accepted the withdrawal of the review application and, accordingly, cancelled the public hearing. The Review Applicant advised the Board that it had reached an agreement with MPP to adjust the pipeline system.
